SECTION 4: First aid measures	
4.1. Description of first aid measures	
First-aid measures after inhalation	: In case of disturbances owing to inhalation of vapours or mists, remove the victim from exposure; keep at rest; if necessary, seek medical attention.
First-aid measures after skin contact	: Take off contaminated clothing and shoes. Wash skin with soap and water. If skin irritation occurs: Get medical advice/attention. In case of burns, cool affected part with cold running water for at least 10 min. Cover with gauze or clean cloth. Ask for medical assistance or bring to a hospital. Do not apply salves or other substances, unless by doctor's advice. Body hypothermia must be avoided. Do not put ice on the burn.
First-aid measures after eye contact	: Rinse eyes thoroughly for at least 15 minutes. Keep eyelids well apart. Remove contact lenses, if present and easy to do. Continue rinsing. If irritation, blurred vision or swelling occurs and persists, obtain medical advice from a specialist. In case of burns, cool affected part with cold running water for at least 10 min. Cover with gauze or clean cloth. Ask for medical assistance or bring to a hospital. Do not apply salves or other substances, unless by doctor's advice.

4.2. Most important symptoms and eff	ects, both acute and delayed
Symptoms/effects after inhalation	: This product has a low vapour pressure, and in normal conditions at ambient temperature the concentration in the air is negligible. A significant concentration may build up only in case of sprays and mists. In these cases overexposure to mists (e.g. through prolonged use in confined insufficiently ventilated spaces) may cause irritation to airways, nausea and dizziness.

5.1. Extinguishing media

5.3. Advice for firefighters

6.2. Environmental precautions

Do not let the product accumulate in confined or underground spaces. Do not let the product flow into sewers or water courses, or in any way contaminate the environment. In case of contamination of environment compartments (soil, subsoil, surface or underground waters), remove contaminated soil when possible, and in any case treat all involved compartments in accordance with local regulations. For containment :	Contain spilled liquid with sand, earth or other suitable absorbents (non-flammable). Recover free liquid and waste materials in suitable waterproof and oil-resistant containers. Clean contaminated area. Dispose of according to local regulations. If in water: Confine the spillage. Remove from surface by skimming or suitable floating absorbents. Collect recovered product and other waste materials in suitable waterproof, oil resistant containers. Recover or dispose of according to local regulations.
