### 2.3. Other hazards (not relevant for classification)

Other hazards not contributing to the classification : This product is combustible, but not classified as Flammable. The creation of flammable vapour mixtures takes place at temperatures which are higher than normal ambient levels. Do not wait for symptoms to develop. Any substance, in case of accidents involving pressurized circuits and the like, may be accidentally injected under the skin, even without external damage. ## SECTION 4: First aid measures

### 4.1. Description of first aid measures

First-aid measures after inhalation	: Remove to fresh air, keep the casualty warm and at rest. If breathing is difficult, give oxygen if possible, or assisted ventilation. If necessary, give external cardiac massage and obtain medical advice. See also section 4.3.

### 4.2. Most important symptoms and effects, both acute and delayed

Symptoms/effects after inhalation	: Inhalation of fumes or oil mists produced at high temperatures may cause irritation of the respiratory tract. Symptoms of overexposure to vapours include drowsiness, weakness, headache, dizziness, nausea, vomiting, dimming of vision.
Symptoms/effects after skin contact	: Contact with hot product may cause thermal burns.
Symptoms/effects after eye contact	: Contact with eyes may cause temporary reddening and irritation. Contact with hot product or vapours may cause burns.

### 4.3. Indication of any immediate medical attention and special treatment needed

Obtain medical attention if casualty has an altered state of consciousness or if symptoms do not resolve. Seek medical attention in all cases of serious burns. If there is any suspicion of inhalation of H<sub>2</sub>S (hydrogen sulphide), Rescuers must wear breathing apparatus, belt and safety rope, and follow rescue procedures. Send patient to hospital. ### SECTION 5: Firefighting measures

#### 5.1. Extinguishing media

- Suitable extinguishing media : Small-size fires: carbon dioxide, dry chemicals, foam, sand or earth. Large fires: foam or water fog (mist). These means should be used by trained personnel only. Other extinguishing gases (according to regulations).
- Unsuitable extinguishing media : Simultaneous use of foam and water on the same surface is to be avoided as water destroys the foam. Do not use water jets. They could cause splattering, and spread the fire.

#### 5.2. Special hazards arising from the substance or mixture

#### 5.3. Advice for firefighters

- Firefighting instructions : Shut off source of product, if possible. Move containers away from the fire area if this can be done without risk. #### 6.1. Personal precautions, protective equipment and emergency procedures

- General measures : Stop or contain leak at the source, if safe to do so. Eliminate all ignition sources if safe to do so (e.g. electricity, sparks, fires, flares). Avoid accidental sprays on hot surfaces or electrical contacts. Avoid direct contact with released material. Keep upwind.

### 6.2. Environmental precautions

Do not let the product accumulate in confined or underground spaces. Do not let the product flow into sewers or water courses, or in any way contaminate the environment. In case of contamination of environment compartments (soil, subsoil, surface or underground waters), remove contaminated soil when possible, and in any case treat all involved compartments in accordance with local regulations. ### 6.3. Methods and material for containment and cleaning up

## SECTION 7: Handling and storage

### 7.1. Precautions for safe handling

- Precautions for safe handling : Ensure that proper housekeeping measures are in place. Keep away from heat/sparks/open flames/hot surfaces. Use and store only outdoors or in a well-ventilated area. Ensure good ventilation of the work station. Due to the extremely slippery nature of this material, more care than usual must be exercised in material handling practices to keep off all walking surfaces. Floors, walls and other surfaces in the hazard area must be cleaned regularly. Before entering storage tanks and commencing any operation in a confined area (e.g. tunnels), carry out an adequate clean-up, and check the atmosphere for oxygen content, flammability, and the presence of sulphur compounds. ### 8.2.2.3. Respiratory protection

#### Respiratory protection:
