SECTION 4: First aid measures

4.1 Description of first aid measures

- General information: Take off contaminated clothing and wash it before reuse.
- In case of inhalation: If breathing is difficult, remove victim to fresh air and keep at rest in a position comfortable for breathing. Seek medical attention if problems persist.
- Following skin contact: Immediately clean with water and soap followed by thorough rinsing. In case of skin reactions, consult a physician.

5.2 Special hazards arising from the substance or mixture

Combustible.
