### 2.3. Other hazards (not relevant for classification)

Other hazards not contributing to the classification : This product is combustible, but not classified as Flammable. ## SECTION 4: First aid measures

### 4.1. Description of first aid measures

First-aid measures after inhalation	: In case of disturbances owing to inhalation of vapours or mists, remove the victim from exposure; keep at rest; if necessary, seek medical attention.

### 5.3. Advice for firefighters

## SECTION 7: Handling and storage

### 7.1. Precautions for safe handling

- Precautions for safe handling : This material is combustible, but will not ignite readily. Provide adequate ventilation. Use adequate personal protective equipment as needed. Due to the extremely slippery nature of this material, more care than usual must be exercised in material handling practices to keep off all walking surfaces.
