4.3. Indication of any immediate medical attention and special treatment needed

Obtain medical attention if casualty has an altered state of consciousness or if symptoms do not resolve. Seek medical attention in all cases of serious burns. Suitable extinguishing media

6.1.2. For emergency responders

Protective equipment

: Small spillages: normal antistatic working clothes are usually adequate. Large spillages: full body suit of chemically resistant and antistatic material. if necessary heat resistant and insulated.
