4.1. Description of first aid measures

SECTION 5: Firefighting measures

5.1. Extinguishing media

Suitable extinguishing media : Dry chemical, CO₂, or water spray or regular foam. Other extinguishing gases (according to regulations).

6.2. Environmental precautions

Prevent liquid from entering sewers, watercourses, underground or low areas. In case of contamination of environment compartments (soil, subsoil, surface or underground waters), remove contaminated soil when possible, and in any case treat all involved compartments in accordance with local regulations. Note : The Derived No Effect Level (DNEL) is an estimated safe level of exposure that is derived from toxicity data in accord with specific guidance within the European REACH regulation.
